### **Parent Governor Vacancy**

The form should be **returned to the school office latest by 9.00am on Monday 25th March '24.** (If you prefer you can return it by email: office@meridian.e-sussex.sch.uk, FAO Head Teacher, please make sure to forward support emails from two other parents/carers in favour of your nomination, following the format in the form.)

Parent governors play a very important role in keeping the governing board aware of the views of parents and the local community. They are a vital part of our team and I hope that there are parents willing to give their time and commitment to this important role.

#### More than 1 Nomination

If more than one nomination is received, I shall arrange for parents to receive (electronic) ballot papers which will include the candidates' election statements. Completed ballot papers must be returned (via electronic vote/or manually to the school office) to the school no later than 9.00am on Monday 8<sup>th</sup> April

Votes would then be counted at 9.30am on Monday 8<sup>th</sup> April. Candidates may attend the count. I shall arrange for all parents to be notified of the result.

### The Core Functions of Governance

The purpose of school governance is to provide confident, strategic leadership and to create robust accountability, oversight and assurance for educational and financial performance.

All boards have three core functions:

- Ensuring the school's clarity of vision, ethos and strategic direction;
- **Holding school leaders to account** for the educational performance of the organisation and its pupils, and the performance management of staff; and
- Overseeing the financial performance of the organisation and making sure its money is well spent.

Governing Boards must be ambitious for all children and young people and infused with a passion for education and a commitment to continuous school improvement that enables the best possible outcomes. Governance must be grounded in reality as defined by both high-quality objective data and a full understanding of the views and needs of pupils/students, staff, parents, carers and local communities. It should be driven by inquisitive, independent minds and through conversations focused on the key strategic issues which are conducted with humility, good judgement, resilience and determination.

### The Parent Governor Role & Support

As part of the governing board, parent governors should provide **strategic oversight** to a school, **act as a critical friend** and ensure that the school is accountable for its actions. The role requires some time commitment, on average around 4 hours per week across term time, more in weeks of board meetings (8 per year, plus 2 whole board training sessions.)

In legal terms **all governors are equal**, no type of governor is any more important or influential than any other. All governors have a right to take part in discussion on all items, put items on the agenda and so on. The only exceptions to this general rule occur where the child of the parent governor concerned is being discussed or the individual governor has some other direct personal interest in the matter, for example a financial or employment interest.

Parent governors share a **collective responsibility** with other governors and **can never act alone** unless they have the express approval of the full governing board. They are not there to override existing school systems, for example, relating to individual parental complaints. They are a two-way channel of communication, feeding views of parents as a whole into governing body meetings, and then reporting back to parents on decisions reached **without breaking the confidentiality of** the meetings.

Governors are not expected to be instant experts. Parent Governors will be provided with relevant information by the school and the Clerk to Governors. They take part in a short new governor induction course and can take part in other training events to help them learn about their role.
